Ratepayers may notice the final rate in the dollar for some properties is lower than the rate which was proposed by Council for 23/24 earlier in the year. This change is the result of new valuations for UV land provided by the Office of the Valuer General. Adjusting the rate in the dollar down, allows us to compensate for large changes in land values, that would otherwise see the Shire collecting more revenue than planned, and to remain compliant with legislative requirements.

# YOUR RATES Due Dates

The 2023/24 rates are due by **15 September 2023** if paying in full. Alternatively, if you have elected to pay in instalments, an interest rate of 5.5% will be imposed with the due dates provided in the table to the right.

Please contact the Shire if you are having difficulty making the payment dates. If you do not, an interest rate of 6% will be imposed and legal action may be taken if payments are not paid on-time.

# **How to Pay**

Rates may be paid in any of the following ways;

Eligible pensioners and seniors who wish to avail themselves of the Government's pensioner rate rebate scheme must apply to do so within 35 days from the issue of the rates notice and must pay the balance of the rates within the particular year the rates were levied.

# **YOUR RATES**

# **Capital Projects**

**ROADS:** In partnership with the Wheatbelt Secondary Freight network, the Shire is reconstructing sections of Merredin-Narembeen road to improve road freight safety. This road is part of a key transport and infrastructure route which supports our major industries. The budget for improvements to this road in 2023/24 is \$3.75m, which includes a carry forward of some incomplete works from last financial year.

Note - The Great Eastern Hwy, Bruce Rock-Merredin Rd and Merredin-Nungarin Rd are under the jurisdiction of Mainroads WA. Issues with these roads should be reported to them directly. Contact their Northam Office on 9622 4777.

Want to report an issue with a road or footpath? The easiest way to do this is to download the FREE Snap, Send, Solve app onto your phone. You can use Google Maps with this app to pinpoint where the issue is exactly, take a photo of it, add an optional description and send it instantly.

**INFRASTRUCTURE:** The next stage of our CBD redevelopment, Town Centre, is planned for 2023/24 with construction scheduled to commence in early 2024 at an estimated value of \$3m.

Meanwhile, stage 3 of our redevelopment, APEX park, is currently awaiting the outcome of a Lotterywest grant application, which will influence when the park construction commences. So far, \$2m has been allocated for the project from a combination of other grant funding and reserve funds.

**WASTE MANAGEMENT:** Waste Management is also a key focus, and the Shire is progressing with a number of initiatives, including the delivery of an E-Waste recycling facility that will allow community members to safely dispose of electronic waste.

**WATER SECURITY AND SUSTAINABILITY:** The Shire has a focus on delivering a number of Water Security and Sustainability projects in 2023/24 in partnership with other agencies. These include a small scale desalination trial, and upgrades to our reuse water network. We will also be continuing our drainage work throughout the year.

**EV NETWORK:** The Shire is part of the State Governments Electric Vehicle network, and construction will start this year on two fast-chargers located centrally, close to the new town centre. In addition, the Shire has also secured grant funding to install an additional charger. This will assist the Shire in working towards the sustainability of it's own fleet, by including EV's in the future.

TIP PASSES: Residential tip passes will be available on receipt of either your full rates payment, or your first instalment. If paying at the Shire Admin Office, the 2023/24 tip passes can be collected at the time of payment. For rates paid online, tip passes will be available for collection once funds have been received into the Shire's account. If you would like your tip pass posted, please email admin@merredin.wa.gov.au with your name, postal address and assessment number.

Please note, fees will apply if your tip pass is not presented. Your 2022/23 tip pass will expire on 15 October 2023.

**TIP SHOP:** The Merredin Tip Shop officially opened in February 2023, and with the combined effort of the community, the Shire has been able to divert a total of 78.5m³ away from landfill so far. We want to extend our appreciation to everyone in the community who donated their unwanted goods. Your contributions have given new life to these items, making a positive impact on both our community and the environment. The remaining opening dates for 2023 are; 13 August, 14 October and 9 December.



# **Bin Collections**

# **Burning Information**

During the **Restricted Burning** period you may burn, but only with a permit obtained from a local Fire Control Officer. During **Prohibited Burning**, you may not burn at all and in some cases, a Harvest & Vehicle Movement Ban (Shire) or a Total Fire Ban (DFES) may be imposed which will mean certain activities, such as harvesting, may not be undertaken.

For further information, please see the 2023/24 Firebreak and Burning Notice enclosed with your Rates.

Note - Burning period times may be changed should dry periods persist. Advertisement of the change of period dates will occur in the Phoenix, on the Shire website and on Shire social media.
