- This form is accompanied by a Certificate of Currency of Public Liability Insurance to the value of \$10,000,000 and Products Liability to the value of \$10,000,000 for the permit period;
- Evidence of current 3rd party vehicle insurance coverage for the period of the license, (additional to the compulsory personal 3rd party insurance associated with licensing your vehicle);
- Where the permit holder employs another person, a Certificate of Currency for Workers Compensation Insurance;
