- 3. The Shire has undertaken comprehensive searches of its files and records for the duplicate Certificate of Title for the Land (Title), and the Title cannot be located by the Shire despite numerous searches and enquiries.
- 4. Located on the Land is a telecommunications tower (Tower), and leases have been granted to Optus Mobile Pty Ltd (Optus), Broadcast Australia Pty Ltd and Telstra Corporation Limited (Telstra) in respect of the Tower. The Shire is currently in the process of surrendering the existing Optus leases, and granting a new lease to Optus (Optus Documents). It was discovered that the Title could not be located when the Shire sought to lodge the Optus Documents at Landgate.
- 5. I understand that Landgate's issuing records note that the Title was last issued to the Australian Government Solicitors (AGS), solicitors for Telstra, on or around 7 November 2017, following registration of leases in favour of Telstra.
- 6. As the Shire has been unable to locate the Title, the Shire's solicitors contacted AGS to see if they, or their client, held the title. Attached hereto as Annexure 1, is AGS's response. AGS's records show that the title was delivered to Telstra's agent, Deighton Pty Ltd (Deighton). AGS has contacted Deighton, and Deighton advised AGS that its records show that the title was sent by post to the Shire under cover letter dated 21 November 2017 (Deighton's Letter).
- 7. The Shire has been able to confirm receipt of Deighton's Letter, however, has been unable to locate the Title.
- 8. The land is not rateable, as the Land is owned by the Shire, and consequently no rates notice is available.
