

Purpose of Report

Executive Decision

Legislative Requirement

For Council to consider submissions received during the public consultation period, which have been used to update the Shire of Merredin Review of Representation - Discussion Paper; and to confirm Council's preferred option regarding number of Councillors moving forward.

Background

On 3 July 2022, the Hon John Carey MLA, Minister for Local Government, advised of the next steps in the reform process, including the removal of wards for Band 3 and 4 local governments, and a reduction in the total number of elected members based on the populations of districts. The current approximate population of the Shire of Merredin is 3,119 (based on the 2021 census data), and as such, the Shire is required to reduce the number of elected members to a maximum of 7, including the Shire President.

As a result of the advice received from the Minister, Council at its December Ordinary Council Meeting (OCM), held on 20 December 2022, resolved the following:

That Council ENDORSE the discussion paper included as Attachment 15.4A for release to the public for the purpose of public consultation for a period of not less than six (6) weeks, during December 2022 and January 2023. (CMRef#83074)

Following Council's consideration of the public submissions made regarding the Review of Representation Discussion Paper, a report will be submitted to the Local Government Advisory Board (LGAB) which will include a cover letter to the Minister for Local Government, an assessment of the review, and Council's recommendations regarding representation.

LGAB will consider the report put forward by the Shire of Merredin and will subsequently make a recommendation to the Minister for Local Government as to whether or not it should be endorsed. The Minister may then accept or reject LGAB's recommendation.

As part of the implementation plan, any changes ordered by the Government will come into effect across the next two ordinary local government election cycles in October 2023 and October 2025.

Comment

Public Consultation

Following the endorsement by Council at its December OCM, a Review of Representation Discussion Paper was released for the purpose of public consultation. The consultation period commenced on Thursday, 22 December 2022 and was open for a period of seven (7) weeks. The Shire received a total of fourteen (14) responses during the community feedback period, which closed on Wednesday, 8 February 2023, at 4:00pm.

The updated Review of Representation Discussion Paper, inclusive of a summary of the consultation results is included as Attachment 15.1A.

As part of the Review of Representation, Council considered the following scenarios as being appropriate for consideration;

- Reduce the number of Councillors to 7. Under this proposal, the Shire would maintain the current system of representation, but reduce the number of Councillors from 9 to 7 – using a staged approach to implement the change over two election cycles.
- Reduce the number of Councillors to 5. Under this proposal, the Shire would maintain the current system of representation, but reduce the number of councillors from 9 to 5 – using a staged approach to implement the change over two election cycles.

3. Community of Interest: Under the Reform, inclusive local democracy, and relations with Aboriginal Peoples and Communities has been highlighted as a priority. In terms of the Shire of Merredin demography, the population percentage of first nations people has indicated they are potentially a community of interest which are not currently demographically represented within the current cohort of Elected Members. The Shire of Merredin considered if there was a way for Councillor representation to include at least one of the anticipated 7 Councillor positions to be held for traditional owners within the area. No legally appropriate instrument was found to enable this to occur.

Community members who participated in the public consultation were asked to answer a three-question survey with the following questions:

Question 1: What do you think is the ideal number of Councillors for the Shire of Merredin?

The following table provides a summary of the responses received regarding Question 1:

Of the 14 submissions received, the preference for the number of Councillors was 7, which was supported by 86% of respondents.

Question 2: The Shire of Merredin does not currently have wards. Do you have any comment on this?

Of the 14 responses received, 10 provided comments regarding wards. Provided below is the summary of comments:

"Councillors are better accountable when representing a ward."

"Would serve no useful purpose."

"Not needed."

"Better not to have wards, current arrangement suitable."

"We used to have wards, I felt the outlying communities were better served when there were wards."

"I would prefer to have Wards but there are just not the number of people in the Wards anymore to allow for volunteer representation that takes up an enormous amount of time. Our Wards are majority farming communities and being away from your farm is a huge undertaking."

"Wards would be good. Some wards would get things done and others wouldn't, due to the diligence of the councillors."

"No point as local act closed them."

"Allows residents to approach who they feel comfortable with."

"We are very much in favour of the Wards system of representation." (See Attachment 15.1B - Appendix 1 for full comment)

While 6 of the respondents were supportive of a wards system, the Local Government Reform does not allow for wards in Band 3 local governments, so this is not a feasible option.

Question 3: Do you think the Shire of Merredin has communities of interest that should be represented differently?

The following table provides a summary of the responses received regarding Question 3:

Of the 14 responses received, 4 indicated that they thought the Shire of Merredin has communities of interest. Two responses spoke of senior citizens as a community of interest, a third mentioned satellite towns, with the fourth respondent not providing a comment.

Formal Position

On consideration of the submissions received during the consultation period, it is recommended Council endorse the number of Councillors as 7, while also maintaining a no ward structure.

The proposed implementation plan for the change is over two election cycles with a reduction of one position in each of the 2023 and 2025 election cycles.

It is also recommended that as part of the submission to the LGAB, the Shire of Merredin write to the Minister observing the lack of legal instrument which could have allowed a genuine consideration and recognition of communities of interest.

Community of Interest is an element of conducting a ward and representation review. Under the Reform, inclusive local democracy, and relations with Aboriginal Peoples and Communities was highlighted as a priority. The Discussion Paper notes the Shire of Merredin considered if there was a way for Councillor representation to include at least 1 of the anticipated 7 Councillor positions to be held for traditional owners within the area. No legally appropriate instrument was found to enable this to occur.

As there does not appear to be an instrument to allow a non-geographic way of recognising communities of interest, the Shire was unable to consider, and therefore have meaningful and genuine dialogue with traditional owners of the area, to seek their views on if a dedicated First Nations position on Council would be supported, and if so, how this could be achieved in a culturally appropriate way.

The Shire of Merredin submission would also ask the LGAB refer the matter to the Minister for comment.


