6. General Business

General Business and questions from the floor as accepted by the Shire President.

Public Questions:

Mr Miles enquired about why the cost of an adult season ticket for the 2019 – 2020 swimming season at Merredin Pool was more expensive than those at Mukinbudin Pool and Northam Pool, and continued to ask why Council was charging this price. The ACEO advised that we are unaware of how Mukinbudin and Northam arrived at their pricing, however the Shire of Merredin work on a user-pay system to determine our pricing.

Mr Miles also questioned what the breakdown was of his home occupation renewal fee of \$73 and how and where it was distributed. This question was taken on notice and will be addressed on the return of the EMDS from annual leave on the 3rd February 2020.

Mr Anderson made comment and questioned as to why he only found out about the Annual Electors meeting at 2.00pm when the newsletter was shared on Facebook as a post. The Council confirmed that the Annual Electors Meeting had been advertised in the Phoenix, in the local Shire Newsletter and e-newsletter, as well as on the Shire of Merredin website with all advertisements displaying the time and date of the Annual Electors Meeting.

Mr Anderson asked about all the vacancies currently in the council. The A/CEO advised that the recruitment process for all vacant positions was being carried out.
