5. Community Garden: Presentation given to Council by 5 people.
6. Collecting Licence Forms: need written evidence of membership from WSWA. Ring DBCA re group collections.
7. WALGA Roadside Vegetation Workshop: Attending from Merredin: Mike Hudson, Dylan Copeland & Roy Butler.
8. Merredin Shire NRM Consultant Dylan Copeland would like to re-do the Roadside Vegetation Survey (which was conducted several years ago). Mal has indicated an interest. Merredin Wildflower Society supports the idea of another roadside survey.
9. Collecting from Reserves outside of Merredin: Mal to check with DBCA as to which Reserves have not had proper collections done.
10. Notes & Ideas for Tidy Towns Group:
  - Permission needed from Local Govt Authority to pick up rubbish on their roadsides.
  - Training required for collecting on Main Roads (eg Gt East Hwy)
  - Enquire re insurance for volunteers.
  - "Adopt A Spot" – free bags supplied by KABC.
  - Community Garden to be tidied up.
  - KAB Week is 19-25 August 2019
  - Look at tidying up area between the two railway crossings on the north side of the railway line.
  - Notice in Phoenix: "Merredin Wildflower Society would like to join with other members of the community to promote the visitor experience". Ring Mal Harper 0437388292 for more information.
