After conducting a voting process for all positions, it was declared that the positions for the 2020/21 fire season remained the same as the 2019/20 fire season with the exception of former Shire of Merredin Ranger Kim Friis, who was removed from any positions he previously held.

6.0 Brigade Reports

6.1 Chief Bushfire Control Officer

With the onset of the COVID 19 pandemic, the severity of the bush fires engulfing the eastern states and large areas of the eastern goldfields at the start of our fire season are now a distant memory.

Back in early Nov, with DFES resources already deployed to the horrendous fires in the eastern states, the fire at Balladonia was cutting road and rail links and drawing more and more DFES resources.

On Nov 10, John and I were asked to join a DFES phone hook-up with other CBFCO'S and listen to a report from the Balladonia Incident Controller. This was both an enlightening and frightening experience. I heard in real time the complex issues surrounding incident management. My initial thought was that this phone hook-up would lead to a request for volunteers to be deployed out to Balladonia, but instead I was asked if we had any concerns about our own level of resources if we had a significant fire because DFES assistance may be limited. DFES asked us to take every precaution to reduce our fire risk. (NOTE we had FRS, SES and BFB volunteers register for deployment, I believe four went).

During this November period, Merredin Bush Fire services had its own structural issues. With a newly elected Shire President, the staff changeover of the Shire CEO, the Shire Ranger, the Shire Works Forman, placing a lot of the BFS responsibilities on the Acting CEO, Kellie Bartley. The two operational issues that occurred at this time was Water Corp ordering the Shire to lock up the standpipes, and the Solar Farm, Monford Construction pushing the boundaries on TFB and HB compliance.

I wish to acknowledge the timely assistance given to me by the then DCEO come Acting CEO Kellie Bartley. Kellie was contactable 24/7 to roll out the TFB and HB

whisper SMS, authorize Shire works resources, and getting the standpipes unlocked and the many other issues that arose this year.

With these past disruptions in mind , I am prepared to continue my role as CBFCO, for another year, if nominated, but ask that your due consideration be given to the election of the DCBFCO, as I have already passed the maximum ten years I set myself.

Water catchment reserve , crown vested in the Shire, DEPAW have mitigation but not response , it was Shire problem.

Feb 23 train engine fire – Burracoppin, (FRS 1am)

Mar 30 uncontrolled burn on Chandler rd 3 brigade units and six farmer units while trying to maintain social distancing.

March 31 received notification from Emergency Serv Commission of decision to extend RBP through to the end of April.

May 22 TFB imposed for the 23/24 May super storm. Issue with town residents not aware.

At LG level, we are already imposed a Prohibition On Burning.

May 25 truck stopped on hwy with overheated brake , WAPOL did not request assistance.

May 29 uncontrolled burn railway line west of Burracoppin. 12am – 330 am found nothing.

In summary. 10 TFB, 13 HB, 16 fires for brigades plus the two controlled burns in town during prohibited.

Well done to all those brigade vollies who attended these incidents or were on standby. No injuries or major damage to brigade units or private vehicles. Some scratches and two tyre punctures.

Thanks to new DCEO Andrina, who while busy getting a handle on her new position, made the effort to contact me. Then came Covid 19, self-isolation, phone hook-ups, Zoom meetings and the postponement of our AGM.

Thanks also to new ranger Stacey, hit the ground running in December with the whisper SMS keeping everyone in the Shire informed and now working her way through the PPE distribution and brigade truck servicing. I think enjoying putting HR licence into action. Stacey is keen to get to know you all and work through issues arising in Bush Fire Services. I know our relationship with ranger services has been scarred over three years, that is now past, and we need to reset our understanding of the support role LG plays in helping volunteers to keep our Shire bushfire safe.

Need to accumulate big budget that needs replacing. Speed up replacement vehicle process replacement/operating budget which will be followed up by the Shire.

Shire's Permit books are incorrect. Need to investigate if current books can still be used or need to be replaced in case an issue needs to go to court.

6.2 Shire of Merredin

Stacey Jaskiewicz:

Servicing of all vehicle's is almost complete for the 2019/20 financial year with the two remaining light tankers from Burracoppin and Colgar to be serviced once arrangements have been made with the Captains.

Available to attend brigade meetings with prior notice and organise dates for distributing uniforms, DCEO will also attend.

DFES update, the regional duty coordinator number was provided to the meeting. If unsure of anything when on scene, it is a good number for back up. Chemical spills, road closures, if need Water Corporation or Western Power. Etc. Comms centre can be frustrating, all recorded.

Please send the Shire of Merredin copies of the Permit's to burn.

Andrina Prnich:

Indication from DFES that next year's budget will be increased as per grant request. Budget is based on previous years expenditure, each year the available budget will increase. Ranger is currently undergoing the necessary training in order to maintain the administrative fire permit matters for town site.

Cr Van Der Merwe:

Advised the meeting if volunteers that Councillors are happy to speak direct to the CEO if there are any issues that need to be resolved.

6.3 Burracoppin Brigade

6.4 Burracoppin South Brigade

David Beck

Two fire call outs resulting from lightning strikes, which took 5 hours to shut power off. Issues with main hose on back of truck.

Only 4,000 litres of water available at overhead concrete tank which needs major repairs. This tank takes too long to fill, tank needs to be filled need a new system. Unable to source water out of 50,000L tank as it was decommissioned by Water Corp. Was told the tank was going to be recommissioned in a couple of weeks' time by a Shire employee back in August 2019. Currently using private water.

Waiting on different size fire unit.

6.5 Collgar Brigade

The shed at Collgar is rapidly deteriorating and a replacement shed will need to be quoted.

Having the same issues as South Burracoppin with having to source private water as the tanks require works.

6.6 Hines Hill Brigade

No representative attended the meeting

6.7 Korbelka Brigade

John Flockart

One fire call-out on Crankston Road, attended a fire in Burracoppin fire permits were restricted due to COVID-19. Repeater needs service. 12 watt charger for each handheld needed (CBFCO, DBCO and each brigade). Would like to hold a meeting so that uniforms can be distributed to members.

6.8 Muntadgin Brigade

Darren Major

There has been one fire call out in the last 8 months. Muntadgin has damaged tanks and water resources is a major issue for the Shire, requested water be a priority to the Shire.

There is an issue with the roller door on the fire shed which was reported at the previous meeting in October 2019 and is still to be responded to by the Shire.

Keys for the Muntadgin tanks, which were delivered in September/October also open the South Burracoppin tanks.

9 new recruits through recent meeting.

Noted: The roller door has been re-reported to the Shire Ranger for repairs

6.9 Nukarni/Nokanning Brigade

Two house fires one truck fire people did not take safety seriously air conditioning unit blew up. Phone projection was not working.

3-day fire with no State resources.

There was a total fire ban on 6-7 December which neighbouring Shire did not put out ban notice which makes things frustrating.

7.0 General Business

7.1 Brigade Incident Reports

Monthly incident reports need to be sent to the Shire Ranger prior to be sent to DFES to ensure reports are not misplaced. Week permits are recommended as it can be pointless giving 2-3 day permits. Ranger is to be included in messages when photos of permits are sent around. Risk to resources needs to be completed and submitted to DFES

7.2 DFES ID Forms

Permit books still reflect FESA rather than DFES. Concerns that this would no longer be valid.

Noted: This has since been followed up by Ranger with DFES who have advised that the books are still valid and do not need to be disposed of and replaced.

7.3 Standpipe Keys

Every unit including the FCO's need to have more than one set of keys that work. Shire needs to unlock water standpipes. The new Shire EMDS will need to speak with Stephen Crook as the previous engineer is no longer in the position.

7.4 Vehicle Fuelling

The meeting discussed the process for paying for the re-fuelling of fire vehicles. The previous process of using Great Southern petrol cards is no longer available and volunteers have been paying for petrol with their own personal credit cards which means payments are not reflected in the operational budget. The Shire will investigate what options are available including issuing new petrol cards.

7.5 PPE

Uniforms need to be re-issued after being issued for five years to be compliant with insurance. Protective helmets need to be issued to each volunteer's I.D number. Boots can be re-issued if damaged if they were issued as part of uniform and not personal boots. 30 kit bags are available and more to be ordered.

7.6 Training & Training Dates 2020

DFES will provide training, limit of one trainer per 4 people so will need to give DFES sufficient notice. August is a possible option to avoid clashes with farmers. The issue was raised that training needs to be relevant as current course is to heavy for what is required and training not take up more than 2 days or held on weekends. Cr Van Der Merwe raised the issue that if training is made only relevant to Merredin that if someone moves to another district, they will not have the correct knowledge on what to do. Training remains the same state-wide. There are two volunteer trainer assessors in the area. Need to investigate options.
