# 1 Document Purpose

The purpose of this document is to request a peer support workshop to help the Central Wheatbelt Local Governments to assess their current IPR Frameworks and to identify opportunities to work together to collectively improve.

## 2 Background

The IPR Peer Support program was extended in January 2019 through Local Government Professionals Association (LGPA) and Integrated Planners Network (IPN) with funding from the Department of Local Government Sport and Cultural Industries (DLGSC) and support from Western Australia Local Government Association (WALGA).

In May 2019 Stephen Grimmer the Program Facilitator presented an overview of the program at the Central Wheatbelt LG Professionals Branch meeting with feedback requesting an initial visit to help participants review their current IPR systems and agree ways they can make the best possible use of limited resources.

# 3 Proposal

### 3.1 Scope

The initial scope is for the peer support program to fund an initial visit from Stephen Grimmer to help participants carry out a self-assessment of current IPR systems and practices and to identify opportunities to simplify and improve using proven tools, templates and techniques.
