PROPOSED SURRENDER OF LEASES N105512 AND N105513 (LOTS 70 AND 71 ON DEPOSITED PLAN 148421) – SHIRE OF MERREDIN

The Department of Planning, Lands and Heritage (Department) are currently considering a proposal for the surrender of two crown leases, both in the name of Enid Joy Crook, being:

- Crown Lease 997/1928 (Document No. N105512) Lot 70 on Deposited Plan 148421.
- Crown Lease 1071/1928 (Document No. N105513) Lot 71 on Deposited Plan 148421.

It should be noted that the lessees have provided the required documentation for these leases to be surrendered and this Department has inspected the land and deemed it ready to be surrendered back to the State of WA.





We refer to your letters dated 14 October 2010 and 21 January 2011 on the above topic.

In discussion with Mr Joe Crook on the matter he expressed the continued wish for the rehabilitation work he has been working on this land to continue until the land can be assimilated into Reserve 28406.

To explore this option further a meeting was facilitated between Mr Joe Crook and the local DEC office to find out how this could work out. Joe Crook was accompanied by a representative of the Nukarni Catchment Group at this meeting which took place on 8th February 2011. DEC agreed to provide guidelines to Joe Crook, working with Merredin LCDC support to work on cleaning up the site and revegetating to a standard which would eventually allow assimilation of Nukarni Lots 70 & 71 into Reserve 28406. The support of Merredin LCDC was subsequently confirmed at an LCDC meeting on 11th March 2011.

At this point the Shire of Merredin would like to support the continuation of the rehabilitation work which the Crook family, with the support of Merredin LCDC would like to take as it is a good case of farmers taking ownership for restoration of lands.

The Shire of Merredin will review the offer of a management order for "Revegetation and Parklands" if the planned actions between DEC and the Crook family encounter some obstacles.

We apologise for the time it has taken to respond to your offer but we wanted to exhaust consultations which would lead to the most beneficial outcome.
