- Need to improve participation at Tech Group meetings. If the Secretary of each subgroup could attend, please. These are open meetings if people other than delegates wish to attend.

6 - WBN RRG Internal Reports

6.1 WBN RRG Chairperson's Report - Cr. Wayne Gibson

- Everyone should have a copy of the new guidelines regarding Total Fire Ban (roadworks require water cart etc) – see fact sheet Addendum 10a.
- There was an error in the WSFN Tech Group minutes, the motion to invite R.
 Munns and A. Butcher to the Tech Group meetings requires an amendment.
- WSFN Steering Committee should be a long term set up for the network improvement project to run for next 15-20 years. Processes, Terms of Reference, etc. all need reviewing because all levels of government will be looking at the model. The Project Governance Plan should be reviewed by 42 LGs, not just the Steering Committee. The rules need to be robust and compliant.
- WSFN Tech Group is not currently running as it should. Cr. Gibson believes that Rod and Allister need to be reinstated.
- Cr. Gibson was required to provide feedback to SAC on the current Black Spot project status, on requesting information from six LGs only two responded. LGs need to be more responsive and proactive when asked to provide information.

6.2 WBN RRG Direct Grants, Road Projects, Black Spots, Commodity Route & State Initiatives funding

Summary of the WBN RRG 2021/2022 Funding and Recoup Register as at 20 February 2022 was attached at **Addendum 4a**.

- **Direct Grant Funding** 100% 2021/2022 Direct Grants have been claimed. A summary of the Direct Grants can be found at **Addendum 4b**
- Road Projects As at 20 February 2022, 51% of Road Project Funding had been claimed. The full WBN RRG 2021/2022 Funding and Recoup Register can be found at Addendum 4c
- **State Initiative Projects** As at 20 February 2022, 40% of State Initiative funding had been claimed. Projects are included in **Addendum 4b**.
- **Commodity Route Supplementary Funding** There are no Commodity Route projects in Wheatbelt North for 2021/2022. All previous projects have been completed.
- State and Federal Black Spot Funding as at 20 February 2022, 41% of State Black Spot funding and 38% of Federal Black Spot funding has been claimed. The report can be found at **Addendum 4d**. The State Road Funds to Local Government Advisory Committee (SAC) met on 13 August 2021 and considered the under expenditure in the State Black Spot Program.

The Committee was concerned about the low expenditure in the State Black Spot Program and as a result an agreed action from this meeting was to write to Regional Road Group Chairpersons asking if they can confirm out of session with the Regional Road Group that their 2021/22 State Blackspot program can be delivered in conjunction with the carry over projects from 2020/21.

A copy of this letter is attached at **Addendum 2ac**

On 07/12/2021 the WBN Chair requested justification and a commitment to acquit the funds from the Shires of Chittering, Dandaragan, Northam, Toodyay and York. To date he has only received responses from Dandaragan, Goomalling and York. This is not acceptable and places funding of future Black Spot projects in jeopardy.

NOTE: The original agenda sent out on 23/02/2022 had Goomalling as having not submitted their commentary on Black Spot projects, this was an error, and the Shire did respond. Apologies to David Long for the oversight.

Please note that the WBN RRG Funding and Recoup Register is provided to all WBN RRG councils at the end of each month and shows allocated funding to councils and claims made against specific projects.

The register does not record Federal R2R funded projects, funding for local roads bridge projects or Wheatbelt Secondary Freight Network projects.

As at 20 February 2022, the Subgroup claim status was as follows:

Overall funding claim status 58% claimed.

The Shires provided feedback on the current project statuses and projected completion. No responses received from the Shires of Chittering and Wyalkatchem. Cr. Gibson will follow up with these LGs. The report was available at **Addendum 4e**.

In previous years, if any Local Government had a carryover of funding for two years or more, they were potentially not be eligible for funding in the third year. If the current trend of under expenditure, by the same few LGs, continues, it may be necessary to review this strategy.

Formal letters have been received by RRG Chairs regarding State and Federal Black Spot under expenditure.

If any LG is having issues acquitting Black Spot or RRG funds, they are to advise the WBN RRG as soon as possible.

6.3 2022/2023 WBN RRG Road Project Funding

The indicative funding for 2022/2023 Road Projects is currently \$11,162,233. This is a 6% increase on the 2021/2022 funding.

The MCA submissions have been captured and reviewed by the Subgroups and ranked according to priority and points. The proposed 2022/23 program was at **Addendum 5.**

Where funding applications (MCAs) were less than the Subgroup allocations, the surplus funds were distributed as per the minimum and maximum percentages agreed per Subgroup.

Cr. Forsyth agreed with process discussed to have the 42 LGs review the documents, but it needs a timeline, so it does not drag on.

Cr. Trent – Query on the process versus the timeline.

Alli Hunt – The WSFN need to have a robust Project Governance Plan before next Financial Year.

Road Condition Survey

• Currently running a tender to complete a visual condition survey of Roads of Regional Significance (ROADS 2040) in the Wheatbelt Region. The scope includes uploading the data to the RAMM/ROMAN database for use by each Local Government. There is the option to negotiate directly with the contractor when in your area to complete a survey of other Local Government roads at the Shire's cost. Video of unsealed Roads of Regional Significance will be collected, but no condition rating applied.

Current statistics:

166 deaths in Western Australia in 2021
99 Regional of which 32 were in the Wheatbelt
What can we do better? Please pass on your ideas.
Rod Munns – clear trees.
Cr. Gibson – clearing issues are holding up roadworks.

Terry Delane – LGs are not provided with true findings/causes of crashes. Only general comments provided. The root cause is not published.

Cliff Simpson – Reports are sanitised, but not post code delineated. You can get the information you need from the Crash Tool which records specific details. It is important for Shires to have at least one staff member trained in use of this tool.

Ammar Mohammed (Main Roads) – success rate for Black Spot funding can be improved. For complex nominations consult with Main Roads for design. Can use the

GPS and SLK App. The number of fatalities is concerning. During COVID with travel restrictions we saw higher volumes of traffic which could have contributed to number of crashes. HVS can assist and will attend next Zone meeting.

8.1 Matters arising from Subgroup agenda for endorsement by the Wheatbelt North Regional Road Group:

8.1.1 Moora Subgroup:

The Shire of Wongan-Ballidu requested that they be allowed to change the scope of work on Hospital Road: Project number 3000808 (2km Pavement reconstruction and widen to 8m SKL12.50-14.50) to culvert replacement.

The culverts are in the funded scope of works and upon recent inspections it has been identified that all the culverts are in need of being replaced due to being salt affected. Due to changing the construction method it is anticipated to be completed on budget. After re-costing replacement of these culverts, we would be unable to complete any road widening on this section of road.

The Shire does not require additional funding approval, all costs will be absorbed by the Shire of Wongan-Ballidu.

The Shire is requesting to change the scope of works by replacing culverts at SLK 12.95 and 12.98. This would require 1200x600mm box culverts in a multi barrel configuration. By opening these channels and going to a bridge type culvert you allow for massive flows.

The Shire of Wongan Ballidu is requesting from the Moora Subgroup that they change the scope of works to culvert replacement on this section of road.

A copy of the Request and Photos was attached at **Addendum 10a**.

The Chair of the Moora Subgroup to please advise the meeting how the group voted. Cr. Gibson: The Subgroup voted in favour of the amendment.

Motion for the WBN RRG:

That the WBN RRG endorse the resolution taken by the Moora Subgroup in relation to the Shire of Wongan-Ballidu's request to change the scope of work on Hospital Road: Project number 3000808 (2km Pavement reconstruction and widen to 8m SKL12.50-

14.50) to culvert replacement at SLK 12.95 and 12.98. There is no additional grant funding required. An updated MCA is to be submitted for this project if approved.

The Shire of Victoria Plains sought to reallocate grant funds between two sections of work on Toodyay-Bindi Bindi Road North. The two projects are a pavement reconstruction and seal widening that only required a final seal at SLK 2.30-6.70 (Carry forward project from 2020/21; Project No. 21116863) and pavement reconstruct and seal widening at SLK 8.40-11.98 (2021/22; Project No. 30000804). The 2020/21 project was reduced in scope to reflect the reduction in funding available (initial funding request of \$659,281 and actual funding received \$216,290) from SLK 2.30-6.70 to SLK 2.30-3.74. There is an outstanding \$43,258 to be claimed. The 2020/21 reconstruction works were carried out late in the 2021/22 fiscal year and sealed with an initial seal to get it covered prior to a rain event. In the summer months of the 2021/22 harvest season in November 2021 the seal bled badly and picked up in long strips. An assessment was undertaken on the seal and pavement, and it was determined that the existing seal /primer had not penetrated the base course and was sitting flush. It is determined that the best course of action is to remove the existing seal, dry the base course to achieve dry back and reapply the first and second

seals (two coat seal). To be able to achieve the repair works, the Shire is seeking to reduce the scope of works for the 2021/22 pavement reconstruction works (Project No. 30000804) to reflect the additional costs required to repair the 2020/21 works. This would require a total cost reduction for the 21/22 from the approved \$634,611 (RRG \$423,074; LG \$211,537) of \$125,113 to \$509,498 (RRG \$339,665; LG \$169.833). This would mean that the 2020/21 project cost would be increased by \$125,113 to \$449,548 (RRG \$299,699; LG \$149,849).

8.1.2 North East Subgroup

Shire of Wyalkatchem - Out of Session Endorsement

The Shire of Wyalkatchem requested the Group to rescind a resolution to reallocate funding between their two (2) 2020/2021 projects located on the Cunderdin-Wyalkatchem Rd and the Tammin-Wyalkatchem Rd – the reallocation of funding which was not required at EOFY.

Motion:

To rescind items a) ii and iii of the previous Out-Of-Session endorsed resolution as below – emailed out to Member Council Delegates on 3rd June 2021, and reply endorsement emails received by 9th June 2021 – as requested by the Shire of Wyalkatchem at the 30th June 2021.

Resolution that:

- a) the Shire of Wyalkatchem's 2020/2021 Road Program be revised and endorsed as follows:
- i) The scope of works for the shoulder widening and primer sealing project on the Tammin-Wyalkatchem Rd be altered from SLK 14.21 16.36 (2.15km) to a total 2.59km long similar project on two (2) sections from SLK 17.79 19.86 and SLK 22.07 22.59 (as endorsed via Out-Of-Session).
- ii) The TEC for the larger scope of works in the alteration in i) above be increased from the original \$135,960 to \$165,000 an increase of \$29,040 which is relative to the increase in scope of works.
- iii) The TEC for the 6.3km section to the Shoulder Reconditioned on the Cunderdin / Wyalkatchem Rd from SLK 17.85 24.18 be reduced by \$ 29,040 from the original \$251,850 to \$ 222,810 no change in project scope since expected efficiencies will offset this project cost reduction.
- b) these endorsed program changes be forwarded to the WNRRG for further endorsement.

Alteration to Shire of Wyalkatchem's Current Year (21/22) Road Program

The Shire of Wyalkatchem has requested a change to their current year project on the Tammin / Wyalkatchem Rd to reconstruct a 2km section from SLK 5.10 to 7.10. This

section includes the intersection with De Pierres Rd at SLK 6.06, where the Tammin / Wyalkatchem Rd comes to a stop and heads eastwards. This intersection is a potential blackspot, and the Shire would like to postpone any work on this section to investigate the potential to obtain blackspot funding to improve this intersection. Additionally, there is a 6.85km section from SLK 10.60 to 17.45 that has been shoulder widened and primer sealed over the last 5-8 years and is in urgent need of a reseal. There is evidence of significant pin holing and the onset of potholing on this section. Additionally, there is a short 0.33km section adjacent from SLK 17.45 – 17.78 that has significant tree root damage, that requires reconstruction. Subsequently, the Shire have requested, that the Reconstruction Project from SLK 5.10 - 7.10 be deleted and the funding from this project be re-allocated to the proposed alternative resealing and reconstruction works on this same road from SLK 10.60 - 17.78. I requested an Out-of-Session consideration of this request via email on the 22nd of December 2021, and Delegates from seven (7) Member Councils have since provided emails advising their endorsement for this proposed funding re-allocation request. These emails are collectively provided in Attachment 5. This item has been included as a record of this Out-of-Session approval for this re-allocation of funding and requires formal endorsement by the Group.

Recommendation

That the Shire of Wyalkatchem's current year (21/22) Project on the Tammin / Wyalkatchem be altered as follows:

a) The Reconstruction Section from SLK 5.10 - 7.10 be removed from the Program, and b) The funding from this deleted Project be reallocated to resealing the 6.85km section on this same road from SLK 10.60 - 17.45 and reconstructing a short 0.33km section adjacent from SLK 17.45 - 17.78.

The Chair of the North East Subgroup to please advise the meeting how the group voted.

Cr. O'Connell: The Subgroup voted in favour of the amendment.

9.1 Local Government Roles and Responsibilities - Bridges

The status of Wheatbelt North inspections as at 17 February 2022 was attached at **Addendum 11.**

Tony Humphreys has advised that Level 1 inspections require proper commentary and photographs. Funding for repairs or replacement will not be approved if they are not completed properly. The cost of bridge replacement can be millions and this cost will fall back on LG if inspections are not carried out, so it is imperative that inspections are carried out correctly. Tony Humphreys can do training.

WALGA are looking at running a workshop in May. Shire of Northam offered to host.

9.2 Report on Severe Weather Event Estimates and Claims - WANDRRA and DRFA-WA

All claims for WANDRRA which were administered by MRWA have been finalised. Events which occur after 01 November 2018 are administered by DFES, under the DRFA-WA determination.

Wheatbelt North February 2022

Road Safety Auditing - Saving Lives and Money

Road upgrades that include a road safety audit during the design and/or development phase can be delivered with the confidence they are less likely to need future interventions and upgrades. A good option for Local Governments in regional areas where crash history and benefit cost ratios can be more difficult to demonstrate.

Ensuring this happens starts with a simple policy; implementation of that policy is easier when you have Accredited Road Safety Auditors active in your community.

Austroads Road Safety Audit template for Local Government

The new Austroads Guide to Road Safety Part 6: Managing Road Safety Audits highlights the importance for Local Governments to develop a road safety audit policy. To assist Local Government achieve this, Austroads has produced a policy template that has been endorsed by WALGA and is supported by the Road Safety Audit Panel. Road Safety Audit Training and Accreditation

Successful completion of both the Road Safety Audit Training and Road Safety Engineering courses provides individuals with the opportunity to become accredited road safety auditors. Successful completion of both the Road Safety Audit Training and Road Safety Engineering courses provides individuals with the opportunity to become accredited road safety auditors.

Maintenance and renewal of the road network accounts for two thirds of Local Government road expenditure; formal examination of a proposed road project through the road safety audit process puts Local Governments on the front foot for both improving safety and saving money. CASE EXAMPLE: Avon Valley Local Government Road Safety Audit Project

The Shires of Northam, Toodyay and York recently collaborated to upskill Local Government staff as a panel of trainee auditors for the Avon Valley. Six Technical staff completed the Institute of Public Works Engineering Australasia Western Australia online Road Safety Audit course, followed by a day workshop facilitated by Senior Auditors from Shawmac. Sharing knowledge and expertise in the workshop format allowed Local Governments to identify problem locations and select countermeasures. For example: runoff road crashes are the priority crash type requiring treatment in the Wheatbelt. The project was funded by the Road Safety Community Grant Program.
