Response to the Merredin Shire Council's "Review of Representation" as in the Merredin Community News, dated 7th February 2023.

What do we think is an ideal number of councillors for the Merredin Shire?

We believe that Seven councillors would be an appropriate number considering the population of the shire.

This would include the Shire President, four town [4] councillors and two [2] councillors representing the farming and small outlying town sites and community areas.

The shire of Merredin does not have Wards. Herewith our comments.

We are very much in favour of the Wards system of representation.

In our life time we have experienced both styles of council representation.

When we had Wards, the councillors who were elected, represented either the farming or business or general public in their particular Ward as well as being involved in the overall council management and care for the Shire population.

This gave a much more diverse section of elected members to carry on the business of Local Government and hopefully make them more accountable to their Ward electors or risk not being re-elected.

They would/might also answer their emails and letters from constituents.

[Councillors who do not reply to emails or letters from constituents show a distain for the people who voted for them in the first place.]

The Ward system would also overcome the possibility of Councillors becoming elected on the platform they advertise in their election promises, but once in the chamber, they may pursue their own agendas.

A councillor elected to represent a particular Ward, having first-hand knowledge of his/her area, would be able to present first-hand information about that Ward re the condition of Shire owned buildings, feeder roads and more remote rural roads or any other problem relating to their Ward.

We believe the Shire needs to have Wards that specifically represent the farming community who, whilst their numbers are smaller these days, their total economic contribution to this town and our businesses is enormous.

You only have to drive round the east end of town past all the machinery and farm related businesses to know how much money is spent by farmers in this region in the course of their business.

Not to mention the western business section, with CBH growing exponentially by the year, trucking companies and engineering companies situated that side of town also demonstrating their success.

The old saying was "If the farmers have a bad year, then everyone suffers".

This has been proved correct many times over.

We need to keep the town attractive to locals and visitors, and accessible to our own elderly or disabled and young families, but also the through traffic.

If you can't park your caravan in a convenient place to the shopping centre, or a caravaner gets a fine for incorrect parking, then the word travels like wildfire.....and caravaners will bypass Merredin for some town more co-operative.

We believe that Wards should be re-introduced.

We also believe that there should be compulsory voting for all ratepayers despite the difficulties that this may cause.

Merredin Heritage Project Secures Funding

The Shire of Merredin is one of 38 successful recipients to share in more than \$1million in funding, through the State Governments 2022/23 Heritage Grant Program.

This program provides matched funding to heritage site ners for vital conservation works of heritage places, and funding assistance to local heritage managers to deliver interpretation projects that share the stories of our past.

Merredin will receive \$20,000 for the development and implementation of an interpretation plan for Pioneer Park and the Merredin Water Tower, inclusive of on-site, print and online interpretive materials. Please note, the Shire are working with the State Government to finalise funding for the refurbishment of the Water Tower. These works will not be completed with this grant.

Congratulations also to the Merredin Railway Station Group who also received \$7,712.00 in funding to develop an interpretation plan for the Merredin Railway Museum's Main Display area.
