Behind the Gavel Julie Flockart, Shire President

During these unprecedented times, it is important to take a moment to acknowledge the monumental commitment from everyone within the Shire of Merredin community to stop the spread of COVID-19. I understand the frustration involved with not being able to leave the house, or visit with your friends, or even hold birthday parties, but by following social distancing regulations, you ARE doing your part to keep our community

Although the number of confirmed cases in WA is dropping, this is no time to become complacent or start ignoring the advice of the State Government. COVID-19 restrictions are expected to be in place for at least the next 4 weeks as we come to the end of the suppression stage of the virus. Until we enter the recovery stage, it is essential that we continue to stay home unless absolutely necessary and maintain a distance of 1.5m should you need to leave your house for an essential reason.

The Shire and other key services in Merredin will continue to support the community and local businesses through a number of initiatives and projects over the coming months. Council announced at the Special April Council Meeting that there will be a freeze on rates for 2020/21, and that Council would be streamlining the tender process and reinforcing support of local and regional suppliers. As part of the Buy Local initiative, the Shire has compiled a business database on their website which lists opening hours, contact details, links to social media, and the social distancing measures that local businesses have in place. The Shire is actively engaging with the community through a number of initiatives, including the pairing of community volunteers with those recognized in our community as being more vulnerable or susceptible to being exposed to COVID-19. We have also introduced the Red and Green signs to encourage neighbours to keep an eye on each other. Our team has also been working hard behind the scenes to bring the community a number of events via online live streaming including Morning Melodies and the ANZAC Day Service.

For now, our skate parks, playgrounds, campsites, and other community facilities will remain closed, however we are constantly monitoring the advice released by the State and Federal Government and will update you if anything changes. Our customer service staff continue to be available to assist with your queries and payments over the phone and our DOT services have re-commenced by appointment only. Shire staff are available to help you during work hours 8.30am - 4.30pm, Monday to Friday. Information regarding COVID-19 and the Shire's response will be updated across the Shire of Merredin website and Facebook page, and SMS notifications will be released for important updates.
