MERREDIN ELECTION OUTCOME AND LEADERSHIP ANNOUNCEMENT

On Saturday 18 October 2025, the Shire of Merredin held an Ordinary Postal Vote to elect members to Council. There were four positions up for election, three 4-year terms and one 2-year term. The 2-year term became vacant after Cr McKenzie stood down from Council ahead of the Local Government Elections.

The Returning Officer received a total of 875 votes, which makes 38.4% of the population enrolled to vote. The Shire is proud to see locals giving their voices power by casting a vote to shape the future of our community. Councillors Donna Crook and Lisa O'Neill were reelected for another term, joined by the newly elected Councillors Paul Boehme and Peter Madigan.

A Special Council Meeting was held on Tuesday 21 October 2025 to swear in the new Councillors and elect the Shire President and Deputy Shire President. Cr Crook and Cr Manning were re-instated as the Shire President and Deputy Shire President respectively, and will continue to serve in these roles for another two years.

"Thank you to the Shire of Merredin community who supported our candidates and voted in the local election," Shire President Donna Crook said at the meeting. "I'd also like to thank my fellow Councillors for showing their confidence in Cr Manning and myself by re-electing us as Deputy Shire President and President for the Shire of Merredin. I offer my congratulations to Cr O'Neill on her re-election and a warm welcome to the newly appointed Cr Boehme and Cr Madigan. I'm grateful to our outgoing Councillors - Brad Anderson, Mark McKenzie and Megan Simmonds - for their valuable contributions throughout their tenures. The Council looks forward to working alongside the community to ensure the Shire of Merredin remains a great place to live, work, play and retire."

On behalf of the Shire, we'd like to thank all the residents who voted in this year's election, and wish our Council all the best for the years ahead.

The staff at the CWVC were proud to see families participating during the school holidays and would like to congratulate everyone who entered the competitions.



INFRASTRUCTURE UPDATES

Recent Works

In October, the bowling green at the Merredin Regional Community & Leisure Centre was resurfaced with new turf. This vital update was partially funded by Merredin Civic Bowling Club, including both financial and in-kind support from their members. Main Roads has removed a section of rail on Great Eastern Highway adjacent to the rail yards that is no longer in use, and Telstra has supported the base station servicing Burracoppin (Tank Hill) to improve the 4G experience in the area and prepare for future 5G network updates.

The Shire paused the Crooks Road safety upgrades at the end of October to minimise disruptions to vehicle movements to and from the CBH port during harvest. We are also working on the Hines Hill Road culvert, which will remove the 8-tonne weight restriction on the bridge, intended to be completed ahead of the harvest season.

Upcoming Works

UGL, on behalf of Western Power, has scheduled works on Neening Road in the Hines Hill and Nokaning areas, expected to commence on 16 November 2025 between 7:00am and 5:00pm. The Shire has also recommenced maintenance works on Chandler-Merredin Road which will continue over several months. Motorists may experience short delays during these works and are kindly requested to follow all traffic management directions for their safety and the safety of workers. Your understanding and cooperation are greatly appreciated as we strive to enhance our local infrastructure and road network.

The Shire has contracted out weed slashing and is progressively addressing areas within the townsite as well as Muntadgin. Slashing has been completed on all Shire vacant properties along Great Eastern Highway, the Cohn Creek drain, Lenihan Park, and areas between South Avenue and Woolgar Avenue. These works will be continuing over the coming week.

The Shire is also excited to announce the planned resurfacing of two indoor courts at the MRCLC, subject to a tendering process (see below for details).

HARVEST BANS AND TOTAL FIRE BANS

As we come into fire season, we will start to encounter Harvest and Vehicle Movement Bans and Total Fire Bans.

Harvest and Vehicle Movement Bans are put in place when conditions are such that the use of engines, vehicles, plant or machinery constitute high bushfire risk activities. They are imposed when the expected weather predictions indicate that if a fire were to start, it would be dangerous, destructive and difficult to stop.

Total Fire Bans are declared by DFES when severe weather conditions are forecast, or when widespread fires mean they don't have the resources to fight more.

On Total Fire Ban days, it is illegal to light an open-air fire or conduct any activity that could start a fire, including using barbeques or pizza ovens that burn solid fuel, using welders or grinders outside, or using equipment powered by an internal combustion engine in areas with vegetation.

16 September - 31 October
Permit Required to Burn

PROHIBITED BURNING

1 November - 17 February
Burning Prohibited

RESTRICTED BURNING

18 February - 16 March

As of Saturday 1 November 2025 until Tuesday 17 February 2026, we are now in the Prohibited Burning Period. During this time, all burning is prohibited and firebreaks must be maintained. Further information can be found on the Shire's website here: bit.ly/FireControllnformation




