## **Corella Control Program**

As previously indicated via our post to Facebook, from January 2018 the Shire of Merredin will commence a program to control the corellas that are currently in the Merredin town site. Due to logistical reasons this program will now commence in early February.

The implementation of this program has been deemed necessary due primarily to the corellas causing damage to public infrastructure, parks and private property. The non-native corellas are also competing with native wildlife and putting undue pressure and stress on the area's native ecosystem.

The program aims to achieve success through the use of 'bird scare shot' (a non-lethal tactic employed successfully in many other scenarios researched by the Shire) to encourage wildlife to move on. The 'bird scare shot' will be employed in the early morning and late afternoon during week days. Every effort will be made to ensure its success.

In the unlikely event that that this program fails to encourage the corellas to move on the Shire has been granted a licence to cull the corellas. However, it is the primary aim to employ the 'Bird Scare Shot' effectively and culling will only take place as a last resort.

### **February Council Meeting**

### Dog & Cat Ownership

Pet owners are reminded that it is a requirement under the Cat Act 2011 and Dog Act 1976 that all cats and dogs must be microchipped and registered with their local Council (dogs from 3 months of age, cats from 6 months however microchipping can be done from 6 weeks of age for both). Not only is this a legal requirement but it also assists Council staff in reuniting pets with their owners faster in the event that they are lost.

Residents are also reminded that no more than two (2) dogs and/or two (2) cats can be kept. If an owner wishes to keep more than two dogs or two cats, they must first seek permission from their local Council. It is also a legal requirement that any cat/kitten dog/puppy must be microchipped prior to sale or being given away. Heavy fines apply for the sale/giving of non-microchipped animals.



### **Final Rates Instalment**

Notice of due payment for the final rates instalment (if paying by instalment) for ratepayers for the 2017/18 financial year will be issued 5 February 2018 with payment due by 5 March. Ratepayers who have not paid one or all of their instalments by the due date will be sent a letter from the Shire of Merredin's debt collection agency.

As per Council Policy 3.2, ratepayers who are experiencing difficulty in meeting their rate payments may approach the Shire (prior to the due date - 5 March) and provided you can demonstrate that you are experiencing financial hardship, alternative financial arrangements can be made. As per Section 6.51 of the Local Government Act 1995 interest will be charged as part of the alternative arrangement.

Ratepayers should note that no arrangement will be entered into if such an agreement will not result in current rates owing being paid by the close of the 2017/18 financial year.

### Are You 'Asbestos Aware'?

The Shire of Merredin urges local industry, business and trades to utilise the newly announced asbestos management resources for commercial and non-residential properties.

In an Australian first, the Asbestos Management Handbook for Commercial and Non-residential Properties provides property owners, managers, developers and workers with essential, practical, user-friendly guidelines and tools to manage asbestos-containing-materials (ACMs) in line with requirements. The comprehensive Handbook, Asbestos Management Templates and Fact Sheets can be downloaded from https://asbestosawareness.com.au/commercial-properties/commercial-downloads/.

Designed for a broad audience including property owners, agents, managers, builders, contractors, subcontractors, tradespeople and workers, the Asbestos Management Handbook, Templates and Fact Sheets were developed in consultation with stakeholders from the building, property management and government sectors to improve compliance in the commercial and non-residential property sector.

The Handbook includes a comprehensive list of building types including commercial, industrial, government, recreational, agricultural, hospitality, health services and education facilities, religious, transport and tourism structures. It details the roles and responsibilities for the management of asbestos and ACM, provides examples of best practice and a comprehensive list and images to demonstrate ACMs commonly found in commercial and non-residential properties.

Importantly, the Handbook provides practical guidance on the steps required to adhere to regulations including how to develop and manage an Asbestos Management Plan, an Asbestos Register, the training requirements for workers, and it defines Asbestos Inspections, Surveys, Risk Assessments and the steps required when asbestos removal is in progress.

The Handbook provides a comprehensive list of the many various property types that may be affected by ACM while the Templates (available in Word and Excel) for developing an Asbestos Register, Asbestos Management Plan, Asbestos Removal Record, Workers Training Records, a Model Asbestos Policy and Model Asbestos Management procedures for Contractors and Builders, has simplified what has previously been considered (by some) to be a highly complex maze of information to navigate.
