# CONTAINERS FOR CHANGE

Did you know that in WA we use more than 1.5 billion drink containers a year? That is enough beverage containers to stretch from Perth to Broome! Merredin has been selected as a country refund point for the State Government's container deposit scheme, Containers for Change. The Western Australia Return Recycle Renew is inviting interested community groups, charities, social enterprises, not for profits, service organisations and businesses to apply to become a 'refund point' in the Merredin community. A refund point accepts the return of eligible beverage containers and facilitates customer refunds of 10c per eligible container. Refund points will also need to count and sort containers that are returned and connect with the community to ensure awareness and understanding of the scheme. Logistics providers then make sure that those containers reach the processing facility in Perth, who crush the containers and send them to approved recyclers. You can register your interest as a community refund point by Monday, 21 October 2019 or email procurement@warrrl.com.au. If we all make change, we can make recycling work!


## **REVIEW OF AGRICULTURAL PILOT REQUIREMENTS**

Main Roads have conducted a review of the Agricultural Pilot requirements in consultation with agricultural peak • bodies, including the Farm Machinery & Industry Association of WA and have developed a new simplified system and revised their 'Agricultural Pilot Requirements Flow Chart.' The new Agricultural Pilot requirements are considered a vast improvement on the previous practices followed by the agricultural industry and are also consistent with national requirements. ### **KEY CHANGES/BENEFITS**

- A pilot vehicle is no longer required, outside the Metropolitan Area, until the oversize agricultural vehicle exceeds 3.8 metres, which is an increase from the previous 3.5 metres. This will enable a lot of equipment, such as self-propelled boom sprayers, to be moved without a pilot vehicle;
- An oversize agricultural vehicle can now have a width of up to 8.5 metres while being accompanied by an Agricultural Pilot. The width was previously restricted to 7.5 metres;
- Oversize agricultural vehicle access in WA has been divided into 3 simple zones. The zones are based on the risk of the road, which then determines the pilot requirements for the particular oversize agricultural vehicle. In the lower risk zones, only one Agricultural Pilot is required;
- The number of oversize agricultural vehicles allowed to travel in convoy has been increased from two to three, outside the Perth Metropolitan Area; and
- The 100 kilometer limit from the point of origin to the destination when utilising Agricultural Pilots has been removed.



A Permit or Order is required from Main Roads when driving an agricultural vehicle, including machines, towed implements and combinations, in excess of the mass and/or dimension limits specified below:

- 2.5m in width4.3m in height
- 12.5m in length for a rigid vehicle
  19m in length for a combination
- 42.5t gross mass
- 6t on a single steer axle
  10t on a twin steer axle group (non load sharing) 11t on a twin steer axle group (load sharing)
- suspensions)
- 9t on a single axle16.5t on a tandem axle group 20t on a tri or guad axle group

Follow these four simple steps

- 1. Complete a "Restricted Access Vehicle Operator registration form if this is the first time you have applied for a permit.
- Complete an "Application to List or Update Vehicle machine or towing vehicle.
- 3. Complete the relevant permit application form
- 4. Submit completed forms with your payment details to

The costs of the permits are \$25 for 12 month permits

### APPLICATIONS OPEN FOR WHEATBELT SENIORS HOUSING

The Central East Aged Care Alliance (CEACA) is a collaboration of 11 Local Governments in Western Australia. The primary objective of the CEACA is to provide affordable housing options to older people living in the Wheatbelt Region.

CEACA was established to conduct research in conjunction with the Wheatbelt Development Commission and Regional Development Australia Wheatbelt which found there was significant under-resourcing of housing, health care beds and other age-appropriate related resources across the region. Formed in 2012, CEACA's membership includes the Shires of Bruce Rock, Kellerberrin, Koorda, Merredin, Mt Marshall, Mukinbudin, Nungarin, Trayning, Westonia, Wyalkatchem and Yilgarn.

We are excited to announce that construction of the 71 units across CEACA's 11 Member Councils is now nearing completion. We will have a range of 2-bedroom unit options available for rent as well as up to 7 units for sale across the Shires, depending on sales price and demand.
